


THO WHEELS & TIES TO Tinseltown

Speed, style, and star power are in the DNA of this 1971 Husqvarna 250 Cross. Originally owned by Hollywood film icon Steve McQueen, this bike is the kind of valuable collector's item that results when movies and motorcycles collide – proverbially, of course.

McQueen, once deemed the highest-paid actor in the world, rose to fame in the 1960s and 70s by making a name for himself not only at the box office but also on the dirt track. An avid car and motorcycle enthusiast from early on, McQueen competed in a multitude of national and international races and often allowed his driving experiences to follow him onto the silver screen, as evidenced by his roles in *The Great Escape, Bullitt*, and *Le Mans*, as well as his inclusion in the documentary *On Any Sunday*.

Typical of your average enthusiast, McQueen made it obvious both on-set and in real life that he preferred certain sets of wheels over others. The actor notoriously favored Triumph and Honda motorcycles and even appeared in a promotional video for the latter. However, when Swedish brand Husqvarna arrived in the United States, he developed a taste for the bikes, and they quickly became his favorite. McQueen purchased th 250 Cross featured in this auction in October 1971 using the name of his Hollywood production company, Solar Productions. 


